Duties and Responsibilities

The Wastewater Operator is responsible for operating the wastewater treatment plant in compliance with effluent limitations established in the NPDES permit and managing biosolids in compliance with the District's sludge application permit. Responsibilities include analyzing data to make necessary adjustments to plant equipment and processes; completing and submitting the monthly eDMR report to IEPA; cleaning plant equipment; communicating with staff regarding needed maintenance and repair of equipment; properly maintaining and repairing equipment; communicating with the Laboratory Technician regarding required NPDES permit testing and needed process control testing; operating the gravity belt thickener and belt filter press for proper sludge management; collecting quarterly sludge samples; participating in the ComEd SEM cohort; and performing other duties as may be required.

This position has potential for advancement to Chief Operator.

This position may require on-call availability for weekend rounds and emergencies (on a rotational basis). There is a thirty-mile residency requirement for on-call employees.
